About the Keynote Speaker

The Honourable Mr. Justice Ramsey

Sir Vivian Ramsey studied Engineering Science and Economics at Oxford University before working as a civil engineer in the UK and overseas. During this time he became a Chartered Engineer and a Member of the Institution of Civil Engineers.

After studying law he was called to the Bar in 1979 and was a practising barrister in Keating Chambers and from 2003 to 2005 Head of Chambers. He became a Queen's Counsel in 1992 and practised around the world as an advocate, arbitrator, adjudicator and mediator. He appeared in English and overseas courts and was called to the Bar in Hong Kong, Singapore, Brunei and Trinidad for particular cases in those jurisdictions. He acted as counsel in numerous arbitrations and was appointed as chairman, co-arbitrator or sole arbitrator in some 90 arbitrations including ICC, LCIA, UNCITRAL, SCC, JCCA and other institutional or ad-hoc arbitrations. He was also appointed as a mediator and an adjudicator as well as being an expert appointed by the ICC President and a member of Dispute Review Boards.

He is the current joint editor of Keating on Construction Contracts. He produced the 8th Edition and the recent 2009 Supplement. He was a founding editor of Construction Law Journal and continues as a Consultant Editor. He has edited or contributed to or is a member of the editorial board of a number of other publications. He is also a Special Professor in the Department of Civil Engineering at the University of Nottingham and has recently been appointed as a Visiting Professor at the Centre for Construction Law and Management at King's College, London. In November 2005 he was appointed as a High Court Judge in the Queen's Bench Division and in September 2007 was appointed Judge in Charge of the Technology and Construction Court.

Litigation and Arbitration Group in Singapore. He was the Deputy Head of the Projects and Infrastructure Practice Group at Rajah & Tann where he was a partner from 1995 until 2003 and concurrently served as a partner at Sakinah & Chong from 1997 to 1998. He was also a partner at Wong Partnership in 1994.

In addition to being a member of the Malaysian Bar, Yee Leong is also a member of the Law Society of Singapore, the Law Society of England & Wales and the Academy of Law Singapore.
