CHAIRMAN'S MESSAGE

The first three months of 2006 has seen a marked increase in the level of orders in the construction industry. While many of the new orders derive from the revitalized residential sector and, in particular, the construction of high-end homes, other sectors have also contributed to the sense of activity felt across the industry. Notable among these are, firstly, the large commercial projects such as Orchard Turn and, of course, the Integrated Resorts and, secondly, the considerable streams of orders from abroad. One local contractor, for example, secured a \$1.8 billion contract in one of the Gulf states while at least three Singapore architectural firms are now involved in the largest construction malls ever developed in that part of the world.

Against this backdrop, the Society's decision to launch the inaugural International Conference of Societies of Construction Law is clearly timely. The conference is expected to bring together representatives from at least a dozen countries. It is intended to serve as a major platform for exchange and deliberations of developments which affect this subject across the world. We are honoured to secure the agreement of the member SCLs in Europe, New Zealand and elsewhere to be the first country to host the conference. I look forward to members of the Society supporting this important event.

Meanwhile, it is also pertinent to report that three adjudications have now been conducted under the Building and Construction Industry Security of Payments Act 2004 which came into force on 1 April 2005. While it is too early to suggest that the adjudication regime has been fully tested, initial feedback suggests that the regime has so far worked well. By the time this issue of the Newsletter is in circulation, the Society would have held its briefing seminar on the first adjudications. I am pleased to be able to participate in this seminar together with Christopher Chuah and Michael Chia.

THE WORKPLACE SAFETY & HEALTH ACT 2006 IN A NUTSHELL

The Workplace Safety & Health Act 2006 ("the Act"), which came into effect on 1 March 2006, repealed the Factories Act and embodies the reform of safety and health legislation in Singapore.

The Act is intended to encourage proactive measures to prevent accidents by expanding both responsibility and accountability for safety and health risks at all levels and by instituting higher penalties.

Legal responsibility will be directly imposed on those who create and have control over safety and health risks. These include occupiers, employers, self-employed persons, principals, employees or persons at work, manufacturers and suppliers and persons who erect, install or modify machinery or equipment.

Accountability will be expanded to include risks posed by employers, not only to their employees, but also to members of public.

In place of the prescriptive approach under the Factories Act, this Act has adopted a performance-based approach. To that extent, it allows the party responsible for creating safety and health risks

to discharge their obligations under the Act by proving that he has taken reasonably practicable measures towards ensuring safety.

For non-compliance, corporate offenders can be fined up to a maximum of \$500,000. For individuals, the maximum penalty is a fine of up to \$200,000 and/or imprisonment for a term not exceeding two years.

However, apart from prosecution, there are various other modes of enforcement for non-compliance, including composition fines, remedial or stop-work orders and suspension of certificates.

In the light of the new provisions, it can be anticipated that all stakeholders will be sufficiently motivated to ensure that occupational safety and health are always of paramount importance in the building and construction industry.

RECENT EVENTS

Talk on Programme Management and Evaluation of EOT claims — Joseph Liow

The SCL organised a talk which was presented by the Land Transport Authority on Saturday 21 January 2006. The talk was well attended by over 70 participants and held at the STI Auditorium at Capital Towers.

Participants heard from Mr Low Tien Sio, the Deputy Chief Executive of the Land Transport Authority that LTA would handle over 150 projects each year with each project producing over 100 claims. He explained that through a sophisticated methodology of managing its projects as well as evaluation of extension of time (EOT) claims, LTA has never been involved in any arbitration on issues relating to claims on extension of time in the many years since its inception.

Participants during the three hour event heard from various experienced project managers from LTA as to how LTA develops its master programme schedules for its often complex and extensive engineering works by collaborating with its various prime contractors at early stages. Its contractors are required to provide detailed construction method submissions, methods of progress measurement, identifying critical paths, program logic and with detailed completion dates for various parts of its work.

Three various concepts of assessing Extension of Time claims were discussed, namely the 'Impacted As-planned', 'Collapsed As-Built' and the 'Time Impact Analysis' method of assessment. Participants heard that in the right circumstances, LTA would adopt the Time Impact Analysis method which had the distinct advantage over the other two method of assessment by reflecting efforts to mitigate the delay and by being more accurate as it reflected concurrency of delays. The Time Impact Analysis required a pre-determined as-planned programme as well as an accurate updated information as to progress of works, hence explaining LTA's approach to its contractors requiring frequent and accurate reporting of progress of works.


